MESSIAH LIFEWAYS COACHING PROVIDED A FREE COACH HELPLINE TO INDIVIDUALS IN THE GREATER COMMUNITY 186 TIMES AND MET FOR COMPLIMENTARY DISCOVERY COACHING VISITS 54 TIMES. MORE THAN 125 INDIVIDUALS ATTENDED COACHING WORKSHOPS THIS YEAR. THE COACH ALSO SPOKE TO MORE THAN 300 INDIVIDUALS THROUGH PRESENTATIONS AT CHURCHES AND LOCAL CIVIC ORGANIZATIONS.

MESSIAH LIFEWAYS, THROUGH ITS SUBSIDIARY MESSIAH LIFEWAYS COMMUNITY SUPPORT SERVICES PROVIDES A NUMBER OF IMPORTANT SERVICES TO THE CAPITAL REGION INCLUDING: MESSIAH LIFEWAYS ADULT DAY WITH LOCATIONS IN MECHANICSBURG AND CARLISLE, MESSIAH LIFEWAYS AT HOME, MESSIAH LIFEWAYS REHAB, MECHANICSBURG PLACE: A SENIOR CENTER AND MORE, BRANCH CREEK PLACE: A SENIOR CENTER AND MORE, AND MESSIAH LIFEWAYS CONNECTIONS.

THIS YEAR MESSIAH LIFEWAYS COMMUNITY SUPPORT SERVICES SAW GROWTH IN ITS TWO SENIOR CENTERS IN CUMBERLAND COUNTY - MECHANICSBURG PLACE AND BRANCH CREEK PLACE (IN SHIPPENSBURG). IN TOTAL, MORE THAN 600 OLDER ADULTS WERE SERVED THROUGH THESE TWO SENIOR CENTERS. BOTH BRANCH CREEK PLACE AND MECHANICSBURG PLACE ARE PROGRAMS OF MESSIAH LIFEWAYS AND ARE SUPPORTED, IN PART, BY A GRANT FROM THE CUMBERLAND COUNTY OFFICE OF AGING AND COMMUNITY SERVICES, THE PENNSYLVANIA DEPARTMENT OF AGING, AND THE US DEPARTMENT OF HEALTH AND HUMAN SERVICES ADMINISTRATION ON AGING. MESSIAH LIFEWAYS OVERSAW THE RENOVATION WORK AND JOINED WITH MEMBERS IN CELEBRATING ITS OFFICIAL OPENING IN MAY 2015. IN ADDITION, MECHANICSBURG PLACE RECEIVED A STATE GRANT FOR \$35,839 FOR KITCHEN UPDATES, NEW FLOORING, NEW ROOM DIVIDING PARTITIONS, A NEW PATIO AND NEW INTERIOR PAINT.

MESSIAH LIFEWAYS, THROUGH ITS SUBSIDIARY MESSIAH FAMILY SERVICES D/B/A MESSIAH LIFEWAYS AT MOUNT JOY COUNTRY HOMES, BEGAN CONSTRUCTION OF PHASE 2A OF A MULTI-YEAR EXPANSION PROJECT. TEN OF THE EIGHTEEN COTTAGES IN PHASE 2A WERE BUILT THIS YEAR.

MESSIAH LIFEWAYS, THROUGH ITS SUBSIDIARY MESSIAH HOME D/B/A MESSIAH LIFEWAYS AT MESSIAH VILLAGE ("MESSIAH VILLAGE"), CELEBRATED THE COMPLETION OF THE INSTALLATION OF A NEW HVAC SYSTEM WITHIN THE 124 APARTMENTS ON CAMPUS. THIS WAS A HUGE UNDERTAKING WHICH REQUIRED MOVING OUT RESIDENTS FOR ONE WEEK WHILE THE WORK WAS COMPLETED. THE NEW SYSTEM ALLOWS FOR TEMPERATURE CONTROLS TO BE MANAGED WITHIN INDIVIDUAL APARTMENTS. NEW FULL-SIZED WASHER AND VENTED DRYERS WERE ALSO ADDED TO FURTHER ENHANCE MANY OF THE APARTMENTS.

THE COST OF PROVIDING BENEVOLENT CARE WAS \$2,311,000.

IMPROVED SEARCH ENGINE OPTIMIZATION AND INTEGRATION BETWEEN ALL THREE SITES WAS PART OF THIS PROJECT. IN ADDITION, A NEW 30-SECOND COMMERCIAL WAS DEVELOPED AND LAUNCHED ON LOCAL NETWORK TV TO PROMOTE ALL THAT MESSIAH LIFEWAYS OFFERS TO ADULTS 55 AND BETTER.
