THE ORGANIZATION CONTINUES TO ADVANCE A NUMBER OF SIGNIFICANT STRATEGIC INITIATIVES. PROGRESS CONTINUES TO BE MADE ON THE FERNECREST PROJECT, A NEW RESIDENTIAL LIVING PROJECT LOCATED 6 MILES FROM THE MESSIAH VILLAGE CAMPUS. 131 UNITS ARE ANTICIPATED TO BE CONSTRUCTED IN A FIRST PHASE OF DEVELOPMENT ON THE CAMPUS.
